While the name may sound familiar, this Blazer is an all-new vehicle. It has undergone various transformations since the 1960s, from a two-door SUV with a removable top to a compact SUV based on the S-10 pickup truck. Equipped with a standard 2.5-liter four-cylinder engine generating 193 horsepower, the Blazer may leave some underwhelmed for its size. The optional 3.6-liter V6, producing over 300 horsepower and capable of towing up to 4,500 pounds, is the more enticing choice. Inside, the Blazer offers a plethora of available equipment, including Apple CarPlay, Android Auto compatibility, adaptive cruise control, and forward collision mitigation.
